1. By entering the prize draw you are agreeing to these prize draw terms and conditions.

9. The winner will be drawn at random from posts with all correct answers.
10. The prize is non-exchangeable, non-transferable and no cash alternatives will be offered.
11. We reserve the right to substitute prizes with another prize of equal or higher value if circumstances beyond our control make it necessary to do so.
12. The decision of Marvel at Everything regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
