Win a Sign Prize Draw Terms and Conditions

1. By entering the prize draw you are agreeing to these prize draw terms and conditions.
2. The prize draw is being offered by Marvel at Everything.

Eligibility to enter

Installation may be included at our discretion depending on the complexity of the installation. Two sign designs will be developed from the brief outlined by the prize draw winner. Two rounds of amends are then permitted after the initial designs have been presented, with any amends after this being charged at our hourly design rate. 8. To enter the prize draw simply post a picture of your room / business that needs a new sign and tell us what sign you need on the Facebook prize draw post.
9. The winner will be drawn at random.
10. The prize is non-exchangeable, non-transferable and no cash alternatives will be offered.
